

SUMMARY ANNUAL REPORT FOR ASPIRUS INC WELFARE AND FLEXIBLE BENEFIT PLAN

This is a summary of the annual report of the Aspirus Inc Welfare and Flexible Benefit Plan (Employer Identification Number 39-1328331, Plan Number 555) for the plan year 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Aspirus Inc. has committed itself to pay certain medical, dental, short-term disability and employee assistance program claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Federal Insurance Company, The Lincoln National Life Insurance Company, Reliastar Life Insurance Company, Wyssta Insurance Company Inc., and Wyssta Insurance Company Inc. to pay certain AD&D, long-term disability, opt LTD, life insurance, AD&D, opt child & spouse life, opt. spouse AD&D, opt. AD&D & opt. life, accident vol employee, critical illness vol employee & dependent, hospital confinement voluntary employee, vision claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$7,100,708.
