Newborn Readmit

This workflow will walk you through the readmission of a newborn to the hospital.

1. Find your baby Holly in AWH NICU department.
 - a. Patient list → Under Available lists → Wausau Hospital → All Nursing Units → NICU- Neonatal Intensive Care.
2. Click the **baby's Holly** to open the chart.
3. Click on the **Navigators Button**.
4. Click on **Newborn Readmit** to open the Newborn Readmit Navigator.



Readmission – Review and Document on your own.

Check Show Row Info, Show last Filed Value, and Show All Choices on the top of the navigator.

Time: Adjust your time to reflect the correct time you did your assessment.

Note: Once in the Newborn Readmit Navigator, follow the links in the Navigator from top to bottom to complete the Readmission workflow.

1. Click on **Readmission**. Review this section and chart on your own.
 - a. Follow up with your preceptor if you have any questions.

Move your way through the navigator by clicking Next.

1. Care Everywhere: Care Everywhere eLearning is available on HealthStream.

2. Armband Applied
 - a. Choose **ID, and Security Transmitter - Baby, when applicable** (document the transmitter number).
3. Home Meds – **Add a Pharmacy**
 - a. **New Prior to Admission Med**
 - i. If the baby was on any Home Meds, you would add Home meds in the New prior to Admission Med window. For this baby there are none.
 - ii. **RN Completed**
 - iii. **Mark as Reviewed**
4. Allergies
 - a. Select **No Known Allergies**
 - b. Review Complete. Select **Mark as Reviewed**.
5. Filed Documents
 - a. Shows a patient's filed legal documents. When you see hyperlinks you can click on them to review the documents.
6. Belongings – Chart on your own.



Transfer

1. Admission Info
 - a. Review this section as it will only be completed for infants being transferred IN from another facility.



Screens

Note: There are several sections in the Screens portion of the Navigator, and they may not all be applicable. If you would like to close any sections, click on the arrow to the left of the row name.
